Dear Madam or Sir,

We are pleased to inform you, that for our thermoplastic products

Durethan[®], Pocan[®]

we have successfully completed the third and last transition phase (phase III) within REACH comprising the registration of substances in volumes of between 1 to 100 tonnes per year (t/a).

The European regulation on the registration, evaluation, authorization and restriction of chemicals (REACH Regulation)* regulates the registration of substances manufactured in or imported into the European Union in quantities of more than one t/a.

Since REACH came into force, about 1000 substance dossiers have been submitted by the legal entities of the LANXESS Group to the European Chemicals Agency in Helsinki (ECHA).

For registered substances in our product range we will inform you of the assigned REACH registration numbers via updated safety data sheets (SDS).

You will receive an extended safety data sheet (eSDS) for each registered substance meeting the criteria for classification and registered above 10 t/a. It will contain exposure scenarios for registered (identified) uses.

In registering our substances we have included all substance-specific uses by our customers that are known to us. Many thanks for your support and for the information you provided.

Please note the following special cases: An eSDS does not need to be generated for substances not subject to labelling requirements, substances registered below 10 t/a or substances registered as intermediates in accordance with REACH Article 17 or 18.

Polymers — like above named thermoplastic products — are exempted from the obligation to register under REACH. For this reason you will also not receive an eSDS for any of our polymer products (plastics).

The REACH relevant substances used for the production of our polymers come from registered sources if you obtain products from LANXESS Deutschland GmbH and LANXESS NV.
